This policy applies to everyone at the JKSML and its all stake holders.


Principles to be observed:

Procedures:

1. The JKSM will develop clear guidelines for staff, volunteers and to all stakeholders to adopt sound environmental work practices, and adequate training will be provided to ensure these practices are carried out.
2. Will act promptly and responsibly to correct incidents or conditions that endanger health, safety, or the environment. It will report any such incidents to the relevant authorities promptly and inform affected parties as appropriate.
3. The JKSM will in its operations minimise materials and energy use, prevent air, water, and other pollution, and dispose of waste safely and responsibly.
4. The JKSM will in its operations conserve energy by improving energy efficiency and giving preference to renewable over non-renewable energy sources when feasible.
5. The JKSM will, where appropriate, utilize its particular knowledge and experience to contribute to environmentally sustainable techniques, technology, knowledge and methods.
6. In order to continually improve its environmental management system JKSM will conduct rigorous audits and self-assessments of its compliance with this policy, measure its progress against its environmental goals, and report its success periodically in its annual reports and elsewhere.
7. The JKSM will maintain an open and honest dialogue with staff, volunteers, stakeholders, and the public about the environmental, health and safety performance of our operations and services.
8. The JKSM will ensure that every employee and every contractor is informed of and expected to follow this policy and to report any environmental concern to management so that prompt action may be taken.


Responsibilities
